Dear Parent / Guardian,


Orrvale Primary School is looking forward to another great year of teaching and learning and would like to advise you of Orrvale Primary School's voluntary financial contributions for 2026.

## Financial Support for Families

Orrvale Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

- CSEF is available to families who hold a current health care card or are on a Centrelink pension. Information will be sent home
- State Schools Relief is an organisation associated with schools who can supply new school uniforms and shoes to eligible students. Please enquire at school office.
- Local community supports, including our Parents and Friends Club are sometimes available to help families suffering hardship.
- Second-hand uniforms if available. Please contact school.

## Payment methods

Parents and guardians will be provided with early notification of annual payment requests (a minimum of six weeks notice prior to the end of the previous school year). Reasonable notice will be given for any other payment requests during the year (i.e. Camps and additional excursions or activities) Costs will be kept to a minimum with payment requests / letters fair and reasonable.

## Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred. All refund requests must be made in writing eg: via email.

Where payment has been made for contributions and a student is exiting the school, a pro rata refund may be applicable less the cost of:

- Student stationery pack
- Replacing lost or damaged books or school owned resources.



# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW



### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
